Keatan King presented Jane Cooper and Ruthie Waldrop this award. This honor is bestowed upon women and men whose gifts, leadership, commitment, and service are considered exceptional by the consensus of the PW Coordinating Team. Along with a certificate, a Lifetime Membership pin was given to them.

Thank you and congratulations to Jane and Ruthie.

Honorary Life Memberships are rooted in a tradition that began in 1912. It is a select

group who has been so honored over several generations. The contribution made in their honor will support training women for future leadership in the church.

The Honorary Life Membership pin's design was adopted in celebration of the coming together of Presbyterian Women from the former United Presbyterian Church in the U.S.A. and the Presbyterian Church (U.S.).

- †The caring, supportive hands represent women who seek to build an inclusive community of Presbyterian Women.
- †The leaf represents growth of our personal and corporate response to Jesus Christ as we nurture our faith.
- †The dove indicates our work for peace in our own lives and throughout the world, shown in the globe.
- At the center of the design is the cross, by which our sins are forgiven and we are freed to live in Christ who is at the center of our lives.
- † The overall design is of the butterfly, a symbol of newness in Christ and emergence of new creation, Presbyterian Women.

The Mission Committee is making plans to collect items for Seafarer's Christmas Boxes. Bins will be available in the Gathering Area each Sunday during the month of October for your donations.

Ship crew sizes average 22 Seafarers to gift per ship. In 2022, the Seafarer's Christmas Gift program received and distributed 9,173 gifts on-board 403 ships which represented Seafarers from more than 61 different countries! These gifts had been donated to the Seafarers by over 179 churches, organizations and individuals! The Christmas shoeboxes are personally carried to each ship by Houston International Seafarer Center Staff, Port Chaplains, and Ship Visitors – *Your* Staff of Chaplains and Ship Visitors, as the ecumenical ministry is funded by all denominations. They begin delivering boxes after Thanksgiving and continue gifting Seafarers until all the gifts have been distributed! Chaplains are gratefully prepared to receive the gift boxes that we pack and wrap.

News of these boxes reaches far and wide with great anticipation. Sailors from all over the world hope to be in port in Houston during the Christmas season to receive the famed Christmas Boxes. One such Captain was so excited with his box, that he video taped himself opening his box while talking to his family online. His daughter was so moved by the gift, that she started a campaign to give Christmas Boxes to underprivileged people in their hometown in Ukraine.

OCTOBER 15T WORLD COMMUNION OFFERING

On World Communion Sunday (**October 1** this year), a gift to the PC-USA's annual Peace and Global Witness Offering promotes the Peace of Christ by addressing systems of conflict and injustice across the world.

Because the impacts of climate change disproportionately affect low income communities and communities of color in Texas and around the world, St. Philip's Peacemaking and Social Justice Committee has recommended that the Texas Coastal Exchange receive the 25% of the offering retained by our congregation to connect with the global witness of Christ's peace.

Texas Coastal Exchange (TCX) is a nonprofit conservation organization dedicated to supporting the long-term resilience of the Texas coast by working with coastal landowners to conserve and protect coastal marshes, prairies, and bottomland hardwood forests.

Donations to TCX will be used to provide grant support to landowners whose properties are providing ecosystem benefits like carbon storage, flood mitigation, and wildlife habitat. To learn more about Texas Coastal Exchange, visit their Web site at https://www.texascoastalexchange.org/

The Presbytery of New Covenant receives an additional 25% for ministries of peace and reconciliation, and the remaining 50% goes to the Presbyterian Mission Agency to advocate for peace and justice in cultures of violence, including our own, through collaborative projects of education and Christian witness.
